## Stottesdon and Sidbury Parish Council

## Annual Parish Council meeting held on Monday 20<sup>th</sup> May at 7.30pm in Chorley Village Hall.

## 1) Election of Officers:

a) Chairman:

Current Chairman Cllr D Young had sent apologies, but Clerk had checked to see if he was still prepared to stand as Chairman and if it was legal to do so in his absence. Cllr Young was prepared to stand, and this was acceptable if agreed by Cllrs that he signs his declaration asap. With this confirmation nominations were taken, and Cllr Young was proposed, seconded, and **RESOLVED to continue as chairman**.

b) Acceptance of Office by Chairman – **RESOLVED for Chairman to sign this declaration** asap.

c) Election of Vice-Chairman:

Cllr Griffin was proposed, seconded **RESOLVED as Vice-Chairman** and took over chairing the meeting.

d) Acceptance of Office by Vice Chairman – this was signed by Cllr Griffin and witnessed by Clerk.

e) Election of SALC reps and any others as deemed necessary:

SALC – Cllrs Abbiss and Griffin elected.

Personnel Committee: Cllrs Allen, Crawford, Griffin agreed to remain on the committee with the addition of Cllr Adams.

## 2) Co-option of Parish Councillor; no interest at present.

3) **Public participation** – meeting suspending for this item at 7.40pm.

Residents present raised their concern regarding the road closure at Brooksmeeting resulting in extra traffic, including HGV's and tractors and trailers who fill the roads, and speeding vehicles with very few passing places.

Clerk explained that the closure was on safety grounds and that she had asked for a temporary speed limit and possible restriction for HGV's, tractors etc with access only and a request from the owner of Dessert Woods for access to be allowed for him to get his charcoal out of the woods and the reply from highways was:

I will ask my supervisor about Dessert woods access tomorrow.

With regard to the extra traffic, all I can say at the moment is that the repairs and being arranged and once they have been completed, we will then move on to Rays Bridge and Brooksmeeting to effect repairs there also.

If anyone reports further subsidence at Rays bridge as a result of increased traffic, please let me know,

I don't think we can restrict vehicle access on the diversion at this time?

Clerk explained that there is a 12ft drop where the road is closed.

## 13) Parish problems:

Report from Cllrs:

- Duddlewick Lane to Pickthorn Farm needs attention. This road is used be walkers, horse riders and vehicles and it is understood that a motorcyclist recently came off his motorbike and was injured.
- Dr's car park road edge has started to dip again due to all the wet weather. Mark Pearce was asked to quote for this work.
- Potholes still remain at Bagginswood.
- Bridleway meeting being held this week, and it is hoped that a five mile off road route has been established.
- Speeding through Chorley due to road closure Clerk has made enquiries but will also email school asking them to remind parents of the narrow lane.

• Duddlewick Lane – a FOI request had been sent to SC and the findings were reported. Part of the lane is collapsing. Main road appears to have dropped down the list of priorities.
