4) Matters arising from minutes:

a. Clerk's report:

Reply from STAR Housing, Tree planting, Glebe Drive: I did manage to speak to Jez briefly, but he is ill at the moment. The instruction that Lewis Arborcare received from Shropshire Council Tree team regarding this one was to remove and replace so that's what they've carried out on this occasion.

I will catch up with Richard and we'll have a look at what options are available to improve the parking situation, we are all aware there is issues, here, as with many other residential areas we deal with unfortunately, and there's never an easy answer.





c. Any others: Designated email addresses for Cllrs was questioned again. Clerk was hoping that Cllr Grey could perhaps help with this but as she was unavailable to attend the meeting, Clerk will email her.

5) Finance:

Cllrs then went through the budget/precept and a total precept figure was calculated as £27,100.00. Clerk pointed out last year the precept was £24,000.00 and in order to keep a 0% increase in the Band D Council Tax Demand, the PC would need £24,564. Clerk felt that with all household bills increasing that the PC could leave the precept the same and take any extra money from reserves. It was RESOLVED that the Clerk requests a precept of £24,000.00 from Shropshire Council.
