# Stottesdon & Sidbury Parish Council

## Parish Council meeting held on Monday 27th March 2023 at 7.30pm in Chorley Village Hall.

## 0) Public participation:

Mr Perry, applicant for 1 Bagginswood attended and gave a brief outline of his plans, which the Chairman thanked him for.

Mr Arrowsmith, applicant for Coulraine, Stottesdon attended in order to answer any queries. Clerk also pointed out that she had followed up a request for information whether a garden shed (approx. 12'x12') needed planning permission or not.

Clerk confirmed that she had contacted the Planning Officer involved and the information had been passed to the applicant. This was discussed and Cllrs felt that as the information was not very clear asked the Clerk to seek further information.

The applicant thanked Cllrs for their help.

Chairman explained to the parishioners that once the meeting opened they would not be able to speak.

# Meeting opened at 7.43pm.

#### 4) Matters arising from minutes:

a. Clerk's report:

B/Way - Burwarton Estate:

Thank you for your email received on Tuesday 28th February regarding the Bridleway along the old railway line. I confirm that your email has duly been passed on to the relevant departments who will investigate this matter further. Thank you for bringing this to our attention.

Cllr Pearce confirmed that he had raised the issue with Lord Boyne previously.

#### Belle Vue Garage, Cleobury:

I hope both issues at Belle Vue/Six Ashes are fixed soon. They have gone on for far too long. Interestingly, there is a planning application for a COU to permit a garage/MOTs at one of the units on the Tenbury Road Ind Est, Cleobury.

I don't know who is going to be running that though.

Reply from SC re: parish problems: Heathcote Bartlett

Thank you for your emails, I visited the lane leading to Pickthorn farm and lane leading to Duddlewick farm yesterday with one of our in house drainage engineers, the road surface problem is not helped buy the water that is running off the fields onto the carriageway, there is no point attempting any permanent repairs until the water that is being discharged onto the carriageway from the fields is addressed.

I will arrange a meeting with the farmers from both farms and our drainage engineer as soon as I can with a view to a satisfactory resolution for all parties involved.

I have also visited the barriers opposite Rays farm they have all been raised and sandbags put in place to hold the barriers in place, this is an ongoing issue that I inherited it appears the land as slipped away, I will need to ascertain ownership of the land in order to progress this ongoing problem. The Almshouse bank area again there are issues with water discharging onto the carriageway, , there is no point attempting any permanent repairs until the water that is being discharged onto the carriageway from the fields is addressed.

I believe I have addressed your immediate concerns, if I have missed anything please feel free to come back to me.

The older issues you have brought up were before my time, I will have a look though in due course and help if I can .

Clerk reported that the issues raised have all been reported via FixMyStreet numerous times. Cllrs Kennett and Abbiss both disagreed that the state of the lanes were not helped by water running off the fields onto Duddlewick Lane and Pickthorn Lane

There are businesses operating up Duddlewick Lane which the state of the lane is deterring people from supporting due to possible damage to their vehicles.

Cllr Kennett expressed his serious concern, and wished his comments recorded in the minutes, that if something is not done with the main road and the lanes, that there is going to be a serious accident, possibly a fatality, and that Shropshire Council may possibly be held responsible.

Almshouse Bank had some repairs but not all.

S. Cllr Harris commented that he has difficulties with FixMyStreet and their reports back and has taken the matter up with Andy Wilde asking that when a job has been fixed it should say 'DONE' and not saying completed when it hasn't been. Clerk confirmed that she had had the same conversation on the Clerks Forum through SALC and highways – 'completed' means it has been passed to the relevant department for action!

#### Operation Snap signs - Chorley: from Heathcote Bartlett:

I have spoken with Mr Keyland this morning, please accept this email as consent for your snap signs to be erected on SC posts.

Hopefully, this might slow traffic down.

#### Chorley Woods - bridge towards Pitt Cottage from Richard Knight, SCC:

Yes, rather up to my neck in things at the moment. Anyway, I will have a look at the bridge, but we are only responsible for foot, cycle and horse traffic over the bridge, not cars! I therefore think the best thing is to make contact with the owners of Pitt Cottage who have the most to gain from a bridge able to take vehicles. Do you know, or can you find out, who lives there now? I do remember speaking to them many years ago, but have lost their contact details and it may have changed.

I did give SC Mr and Mrs Edge's details and for Mr and Mrs Home's who use this bridge and also mentioned Bush Cottage being used as holiday lets.

# 7) SALC report:

Cllr Abbiss reported that Welshampton and Lyneal had received Gold Quality Status for the second time and highlighted what they did in their parish.

# 8) Parish matters/problems:

a) Parish issues raised by Councillors:

- Hinton bridge and Hinton Farm bend not repaired and getting worse.
- Almshouse Bank Duddlewick potholes.
- Brooksmeeting road slipping.
- Rail broken at Brooksmeeting bridge reported by Clerk.
- Bagginswood road round the corner from Jimmy Harris' tarmaced over the drains.
- Sidbury potholes etc
- Bagginswood road single track in places with base stone showing through.
- Application for caravans at Bardley Court dismissed as unlawful.
- Coronation question asked if the PC were doing anything? Nothing arranged. It appears that The Duck Inn are holding events but not sure if the Fighting Cocks are holding any events. Coins will be given to the children but it was felt that parents should make an effort to collect these not expect them to be delivered.
- Dr's Surgery Cllr Kennett could not attend last meeting but did send apologies and Clerk pointed out that Cllr Powell had resigned from the group as the meeting went on too long. The next meeting is 4<sup>th</sup> April, 6.30pm at Ditton Priors Village Hall.
- Broken bridge/overgrown on BW/FP 0146168/1 Chorley Hall to Harcourt.
- Barns at Litley more blocks, building appears to be growing!
- Pickthorn Lane offered to work with SC to fix this lane.
- Grit bins at Walton Bank (Clerk pointed out that this has been removed from the maps she has seen), the bin just round the bend is barely visible and needs replacing with a new yellow bin and Station Road covered in hedge (holly tree)

b) Tree planting – planted at Sidbury. Clerk has not received permission from SC to plant at Bagginswood and possible too late for Glebe Drive now.

c) Community Hubs - Chorley still operating

d) Speeding through Chorley: Operation Snap signs received from Police to put up in Chorley, but no further information received from Traffic Engineering Dept.

e) Stottesdon Footpath 57/5 (part) Diversion – dealt with last month.

f) PROPOSED ROAD CLOSURE - BULL RING DY14 8UD – 2<sup>nd</sup> April 8-4pm Severn Trent – road closed from top of Glebe Drive to The Bull Ring.

g) Road Name signs - request sent in by Clerk added to FixMyStreet by SC.

h) Kings Coronation – coins ordered, dealt with earlier.

i) The update to your defibrillator record is now overdue – The Circuit. MedUk do not do this so it was suggested to ask Cllr Allen if he could do it to save Cllr Powell as we are aware that he is not always well. Cllr Abbiss said she would ask Joe Williams if he would check Sidbury.

j) any others – none.

- 9) Shropshire Cllr's report emailed to Cllrs.
  - Cllr Harris suggested that the PC invite Lezley Picton and Andy Wilde to the Annual Parish meeting on 17<sup>th</sup> April at Chorley Village Hall to talk about the highway issues. It was RESOLVED that Cllr Harris would ask if they would be available and Clerk will follow this up.
  - SC Consultation regarding opening hours
  - Rough sleepers/homelessness 125 people in Shropshire. Warning that some could be 'organised begging'.
  - Clerk mentioned the problem raised on Facebook where a man had tried to tempt a child to go with him for sweets luckily her friend turned up and he ran off. Cllr Harris was not aware of this, and Cllr Butler had not mentioned it to him earlier.
