Parish Council meeting held in Chorley Village Hall on Monday 23rd September 2024 at 7.30pm.

0) Public participation:

Steph Eddies-Davies from Country Treks attended the meeting to outlie plans regarding bridleways.

Steph introduced herself to everyone and thanked Cllrs for allowing her to attend.

Steph has been in the village for 35 years and runs Country Treks and a school for children with additional needs.

The problem with overgrown bridleways and some shutting up has become a problem for horse riders. There used to be a scheme years ago where farmers were given a small amount of money to allow 'permissive' rights of way, but this stopped.

Steph is aware of the budget problems with SC and formed a small group of horse riders (36 at present) to try to work out a solution. It is well known that motorists are not keen having horses on the road, but due to restricted bridleways they have no option.

Steph has approached numerous landowners with the hope of working with them to use their field edges from April onwards but to stay off from November-March. The group will 'chip in' a subscription which can be paid to farmers in the scheme with the understanding that they will stay off the fields, if requested.

This suggestion has been met with quite a lot of support from landowners who have been approached, who are happy to see the horses 'off the road'.

Councillors felt that this was a very good idea and welcomed Steph to attend further meetings with progress reports.

Chairman thanked Steph for attending and she left the meeting.

a. Clerk's report:

Honeysuckle Brook/bridge:

Hello Freda,

Our contractor has informed me of the following.

"The works at Honeysuckle bridge 11-13/09/24, were delayed on Wed as the paint had not been delivered.

We delayed the start so we could investigate the issue with the paint.

The paint was ordered 5 weeks ago, with a 2-week lead time, but has still not been received. Kier had to cancel the work as we would not be able to complete the works instructed.

I am sorry you were not notified as you should have been of the delay and then the cancellation."

Roads:

Message left on answerphone re: roads:

Bagginswood – not as hoped, will keep inspecting and repairing!

Duddlewick Road: - Standing water must be sorted, no concrete information yet, due to budget problems

Hawkswood road commenced, but no date for Rays Farm slippage again due to budget problems.

Hedge removal, Station Road and Chorley:

Clerk had emailed Cllrs reply from James Griffiths regarding the hedge removal. Reply was: Further to our phone call, the gap in the hedge at the bottom of Station Road was created to get welfare facilities and equipment across the field, where the current access would not allow. The hedge was coppiced after first checking it for nesting birds.

As it was coppiced it will grow back nicely, coppicing is not hedge removal, but a traditional and sustainable way of rejuvenating a hedge and an ideal way to create a temporary gap for what ever reason.

All original gates and fences will be installed, and no new access created as might have been thought.

There is some tall temporary fencing in place whilst the field is grazed and the old fencing reerected.

New Road, Chorley - opposite Village Hall: Reply from SC:

Thank you for your enquiry. The hedgerow regulations deal with hedges that border agricultural or common land and do not apply to any hedgerow within the curtilage of or marking a boundary of the curtilage of a house. If the owners of Rosemary Cottage, New Road, Chorley removed a hedge bordering their own property then they would not have needed to apply to the council beforehand. If the issue is with who owns the boundary (which can probably be found within the deeds or with the land registry), then we would consider this a private matter and something to perhaps bring up with a solicitor.

- SALC office very busy at present.

- Housing Enabling officer spoke at Area meeting. After discussions it was agreed to invite the officer to speak at our next meeting regarding carrying out a housing needs survey for the parish. Cllr Abbiss will pass on contact details to the Clerk.

8) Shropshire Cllr's report:

Shropshire Cllr Harris reported:

- No money will be forthcoming from the HS2 money.
- Green bins difficulty in booking these, should the deadline be extended? It is noted from social media posts that people will leave their bins on the roadside if they are not paying for these. Bins planned to be collected next year!

- Quality of pothole patching had been raised by Farlow & Oreton and Kinlet PC's and this
 was debated. Clerk pointed out that she is on a Clerk's Forum and had raised this,
 together with work cancelled at the last minute and being asked to collect up roadworks
 signs. Do the repairs get checked by SC officers, are they happy with the standard?
 It was RESOLVED that the Clerk puts a motion together, sends it to SALC to check
 wording, then Cllr Griffen will read this at the AGM if one of the other PC's will
 support the motion. Is quality of short-term patching cost effective until long term
 repairs are made?
- Cllr Butler sent in motion to Government asking for the decision on winter fuel payment to de reversed.

Chairman thanked Cllr Harris for his report.
