Parish Council, meeting eld in Chorley Village Hall on Monday 28th October, 2024 at 7.30pm.

Guest speaker, Craig Bethel, gave a very interesting presentation on his role in working with communities to identify affordable housing needs and to work with all parties involved in planning, development and construction to ensure those needs are met.

There is a sharp increase in rural home prices (to buy or rent) versus little movement in local wage is having a huge impact in our rural communities. Limited first home and downsizing options are causing long-term residents to move away, whilst local businesses struggle to recruit. Lack of the right affordable housing has an impact on health and wellbeing. There is a need for more community-led affordable homes in rural areas that strengthen the existing community whilst keeping what is important to residents intact.

An impartial community engagement role first and foremost, the Rural Housing Enabler will ensure local needs are heard and prioritized at every stage from needs analyses, infrastructure, identification, design and construction.

Craig answered questions.

The major problem will be in obtaining land at a right price.

Parish Council will be able to put their own stamp on the survey.

Chairman thanked Craig for his attendance and Craig left the meeting.

0) Public participation:

Resident raised the problem of the dogs at The Rectory. There had been an incident in April when the Dalmatian attacked the neighbours dog causing injuries to both resident and dog, We understand that the Police visited and the dog should not be alone in the garden. It appears that there has been another incident when a child with the dog on a lead was struggling to control it on the school car park and that children had been taken back into school. After much discussion it was agreed to write to PC Nolan, Hereford Diocese, Public Protection at Shropshire Council and the letting agents, thought to be Nock Deighton.

Resident came along to explain his planning application 6a, which he did and answer any questions.

At this point, the Clerk suggested residents remain and listen to the Shropshire County Cllrs report, which was brought forward on the agenda:

Cllr Butler confirmed that he would be sending out his monthly report tomorrow.

Following the guest speaker this would be an ideal time to carry out a housing needs survey. Finance:

Employees will be leaving The Shirehall on Friday to hep save money and staff will be working from home before moving into The Guildhall. Cantern Brook, Bridgnorth and other offices around the County will be mothballed for the time being, but in 12/18 months could come back to life.

Shirehall will no doubt be sold off eventually.

Recycling Centres have to book to go from Monday.

Believes SC on target with their budget. Shropshire Council is taking strong action to bring down the in year budget deficit.

At this point Cllr Butler introduced Anita Rose a prospective candidate to replace Cllr Simon Harris, if elected.

Anita has lived in Neen Sollers for 23 years and if elected hopes to work alongside Cllr Butler, who will be standing for election in Cleobury Mortimer.

HS2 money – still unsure regarding this.

It was mentioned to Cllr Butler that the work carried out at Brooksmeeting, did not appear to be of a very high standard and he advised Clerk to report this on Fix My Street.

Although I have not been up this road, it does look as if the work has been competed!

Pothole out again at the bottom of Burnt Pitt bank – I have reported this!

Precept:

SALC suggest that we put into our budget an amount to cover anything we might be asked to contribute to by SC or even Town Council.

As we all know SC are in a poor financial position, and we will be able to contribute if we have it in our budget – if we do not use it the precept can be reduced next year.

Parishioners will not mind paying a little bit extra monthly on their Council Tax if they can see we are helping to do things!

Message from Highways:

Hi all.

The situation currently is challenging due to budgets.

Many resurfacing schemes have been cancelled across the county as there is not the money to complete them. Patch surface repairs, minor works, and other work such as signage and lines, is being suspended for the same reason. Routine inspections, pothole repairs, blocked drainage gullies, gritting and emergency repairs are continuing. I'm afraid this is the situation for the foreseeable future. We have also had a reduction in staff.
