Parish Council meeting held on Monday 24th June. 2024 at 7.30pm in Chorley Village Hall.

Present: Cllrs D Young (Chairman), Z Griffen (Vice-chairman), M Pearce, S Allen,

The Chairman welcomed the parishioners to the meeting and explained this was their opportunity to speak as when the meeting opened it was for Cllrs only.

0) Public participation:

Parishioners in attendance attended to show their concern regarding the road closure and made the following comments:

- Speeding traffic through the whole village
- Overhanging trees, in particular opposite Rays Farm. Everyone is aware of the bird nesting season, but health and safety should come first.
- Verges becoming damaged
- Volume of traffic, which will increase when the harvesting season starts with large tractors/trailers/equipment etc.
- Horse riders are not being given the required space when vehicles passing, as per the new Highway Code.
- Children on bikes/pedestrians are in considerate danger
- Traffic particularly heavier/faster at school times morning and evening
- Insufficient signage to slow people down.
- British Horse Society have been made aware of the problems and have been in touch with SC, but any additional signage requires planning permission.
- Brow of the hill through Chorley woods is dangerous but accept that there is limited space for signs.
- Clerk was thanked for all the help she had given to the residents in Chorley with this problem.
- Trees also need cutting back opposite Yew Tree Farm (Barretts)

Clerk explained all the actions she had taken trying to get more signage, temporary 20mph speed limit, permanent 30mph speed limit, grass verges cut etc., but felt that at times she was 'hitting her head against a brick wall'. The school had been asked to put a notice in the school newsletter asking people to slow down, but Clerk will ask again.

The 30mph requested several times – we are on 'the list'.

Hopefully work on the damaged road will commence end June, beginning July, but until this starts, they have no idea how long the work will take. Hopefully they will then move on to repairing the slippage close to Rays Farm.

The Chairman thanked everyone for attending and that Cllrs had taken on board their concerns and Clerk will action these.

- a) Raised by Cllrs:
 - Verges to Cleobury North and Loughton not yet cut.
 - Hedge cutting sign outside Hillcrest encroaching onto the road causing vehicles to drive round it and unable to see oncoming traffic.
 - Potholes on Bagginswood/Six Ashes Road still not repaired.
 - Ivy encroaching onto the church driveway Clerk was asked if she had Compass phone number? Will try to find it.
 - Horse riders will be trialling an 'off road' course next month.
 - Highlands/Overton Road has very bad potholes.
 - Tree overhanging onto road at Chairman's property with tractors/equipment catching this Chairman will look at this problem.
 - Honeysuckle brook road potholes.
 - Camper van on ramps, partly on the pavement in Glebe Drive and has been for several weeks report to STAR Housing.
 - Potholes along the flat between Hawkswood and Sidbury.
 - Lengthsman: Drains/ditches cleared and working well but need to be kept on top of. The drain towards Prescott Mill needs dealing with by SC as the sand gets washed down into it. Mr Whitehouse has removed sand from his field.
 - Lengthsman asked to carry on with urgent work for safety issues, the grant has been cut by SC, but the PC does have some reserves, which could be used.

Cllr Allen reported that a constructive meeting had been held prior to the PC meeting. A new Job Description had been typed out for the Clerk.
